Ingersoll/Tillsonburg

Deb Landon, on behalf of Big Brothers and Big Sisters of Ingersoll and Tillsonburg, presented the organizations 2019 grant request to Council. She thanked the Township for their support in the past. She commented on funding challenges which they are experiencing as a result of decreased funding from the Ministry of Education. The organization does a lot of fundraising and services up to 235 children each year; the demand for support continues to grow. Deb Landon shared some testimonials from matches with Council.

In response to inquiries from Council, Deb advised that there are currently 67 children waiting for matches and that volunteers are not reimbursed for their expenses. Matches are encouraged to participate in cheap or free activities together; some places will offer discounts to support the program.
