

**THE CORPORATION OF
THE TOWNSHIP OF SOUTH-WEST OXFORD**

BY-LAW NO. 25 – 2011

A By-law to adopt estimates of Revenues
and Expenditures and provide for
the Levying of Taxes for the year 2011.

WHEREAS Section 290 (1) of The Municipal Act, R.S.O. 2001, c.M.25, provides that a local municipality shall in each year prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality including, amounts sufficient to pay all debts of the municipality falling due within the year.... And including the amounts required for any board, commission or other body...;

AND WHEREAS Section 307 of The Municipal Act, R.S.O. 2001, c.M.25, provides that all taxes shall, unless expressly provided otherwise, be levied upon the whole of the assessment for real property or other assessments made under the Assessment Act, according to the amounts assessed.....;

THEREFORE the Council of the Corporation of the Township of South-West Oxford enacts as follows:

1. That statement of Estimated Revenue totaling \$6,669,451 for the year 2011 and the statement of Estimated Expenditures totaling \$6,669,451 for the year 2011 for Township purposes including Taxation and Special Charges per Schedule “A”annexed thereto, is hereby adopted.
2. That the taxes for the year 2011 for Township purposes shall be levied in accordance with the Tax Rates set out on Schedule “B” annexed hereto.
3. That taxes for 2011 for County purposes as per County of Oxford By-Law No. 5260-2011 are as shown on Schedule “C” annexed hereto.
4. That taxes for 2011 for County Library purposes as per County of Oxford By-Law No. 5260-2011 are as shown on Schedule “D” annexed hereto.
5. That taxes levied in 2011 for Education purposes are shown on Schedule “E” annexed hereto.

6. That taxes levied in 2011 shall be due and payable in accordance with the following schedule:

	<u>Due Date</u>
1 st installment (Interim Tax Levy) – all classes	Feb. 24 th , 2011
2 nd installment (Interim Tax Levy) – all classes	May 26 th , 2011
3 rd installment (Final Tax Levy) – all classes	Aug. 25 th , 2011
4 th installment (Final Tax Levy) –all classes	Oct. 27 th , 2011

7 The taxes levied in 2011 shall be payable in any of the following ways:

- At the Municipal Office in Dereham Centre, R.R. # 1 Mt. Elgin, Ontario.
- By internet banking
- By pre-authorized payment
- By telephone banking
- At the Ingersoll, Tillsonburg and Woodstock branches of T.D. Canada Trust.
