## **PRELIMINARY CERTIFICATE OF MAXIMUM EXPENSES AND MAXIMUM CONTRIBUTIONS TO A CANDIDATE'S OWN ELECTION CAMPAIGN**

*Municipal Elections Act, 1996, as amended (s.33.0.1 and 33.0.2)*

Section 88.9.1 of the Municipal Elections Act states a candidate for an office on a council and his or her spouse shall not make contributions to the candidate's own election campaign that, combined, exceed an amount calculated in accordance with that section. This limit does not apply to school board trustee candidates.

Section 88.20 (6) of the Municipal Election Act states that during the period that begins on the day a candidate is nominated under section 33 and ends on voting day, his or her expenses shall not exceed an amount calculated in accordance with the prescribed formula.

In accordance with the requirements of section 33.0.1 and 33.0.2 of the Municipal Elections Act, 1996 as amended, I hereby certify that the maximum amounts described in section 88.9.1 and 88.20 (6) are as follows:

### **Mayor**

Maximum Contributions to a candidate's own campaign: \$8,703 (\$7,500 plus .20 cents per eligible elector)

Maximum Campaign Expense Limit: \$12,612.75 (\$7,500 plus .85 cents per eligible elector)

### **Ward 1 Councillor**

Maximum Contributions to a candidate's own campaign: \$5,171.00 (\$5,000 plus .20 cents per eligible elector)

Maximum Campaign Expense Limit: \$5,726.75 (\$5,000 plus .85 per eligible elector)

### **Ward 2 Councillor**

Maximum Contributions to a candidate's own campaign: \$5,164.80 (\$5,000 plus .20 cents per eligible elector)

Maximum Campaign Expense Limit: \$5,700.40 (\$5,000 plus .85 per eligible elector)

### **Ward 3 Councillor**

Maximum Contributions to a candidate's own campaign: \$5,182.00 (\$5,000 plus .20 cents per eligible elector)

Maximum Campaign Expense Limit: \$5,773.50 (\$5,000 plus .85 per eligible elector)



**Ward 4 Councillor**

Maximum Contributions to a candidate's own campaign: \$5,226.60 (\$5,000 plus .20  
Maximum Campaign Expense Limit: \$5,963.05 (\$5,000 plus .85 per eligible elector)

**Ward 5 Councillor**

Maximum Contributions to a candidate's own campaign: \$5,217.20 (\$5,000 plus .20  
cents per eligible elector)  
Maximum Campaign Expense Limit: \$5,923.10 (\$5,000 plus .85 per eligible elector)

**Ward 6 Councillor**

Maximum Contributions to a candidate's own campaign: \$5,241.40 (\$5,000 plus .20  
cents per eligible elector)  
Maximum Campaign Expense Limit: \$6,025.95 (\$5,000 plus .85 per eligible elector)

**Thames Valley District School Board (English Public)**

The Clerk of the City of Woodstock provides estimated contribution and expense limits.

**London District Catholic School Board (English Separate)**

The Clerk of the City of Woodstock provides estimated contribution and expense limits.

**Conseil Scolaire Catholique Providence (French Separate)**

The Clerk of the City of Woodstock provides estimated contribution and expense limits.

**Conseil Scolaire Viamonde (French Public)**

The Clerk of the City of Sarnia provides estimated contribution and expense limits.

The number of electors used for the final calculation of contribution and spending limits will be the greater of the number determined from the voters' list from the 2022 election as it existed on September 15, 2022, or the number determined from the voters' list for the 2026 election as it exists on September 15, 2026. The contribution and expense limits using the 2022 information have been included in this certificate.

The Clerk will provide a maximum contribution and spending limit calculation using the number of voters eligible to vote in the 2026 election (if the number of eligible voters is greater than that of 2022) to each certified candidate on or before September 30, 2026.

A preliminary certificate of the applicable maximum amounts is hereby given in accordance with the provisions of the Municipal Elections Act, 1996.
