Nominations may be made by completing and filing on the prescribed forms (Nomination Paper – Form 1 and Endorsement of Nomination – Form 2) and accompanied by the prescribed nomination filing fee of \$200.00 for the Head of Council and \$100.00 for all other offices in the Office of the Clerk. The filing fee is payable by cash, certified cheque, money order or electronic payment if specified by the Clerk.

A nomination must be signed by the candidate and may be filed in person or by an agent during regular business hours between May 1st, 2026, and August 20th, 2026, and between 9 am and 2 pm on August 21st, 2026 (Nomination Day).

In the event there are an insufficient number of certified candidates to fill all positions available, nominations will be reopened for the vacant positions only on Wednesday, August 26th, 2026, between the hours of 9:00 a.m. and 2:00 p.m., and such additional nominations, if required, may be filed in the Office of the Clerk.

Electors are hereby given notice that if a greater number of candidates are certified than are required to fill the said offices, the voting period will be opened for the period stated below for the purpose of voting.
